<b>September 1, 2017</b>	Deadline for Write-In Candidates to file a copy of the Notice of Intention of Write-In Candidacy for November General/Special Election. O.C.G.A. § 21-2-133(a)
<b>September 15, 2017</b>	Last day to mail or issue absentee ballots for September Special Election. O.C.G.A. § 21-2-384(a)

<b>October 10, 2017</b>	Last day for a person to register and be eligible to vote in the November General/Special Election and Runoff Election. O.C.G.A. § 21-2-224(b)(2)
<b>October 13, 2017</b>	Last day to mail or issue absentee ballots for October Special Election Runoff. O.C.G.A. § 21-2-384(a)(2)
<b>October 16, 2017</b>	First day to mail or issue Absentee Ballots for November General/Special Election. O.C.G.A. § 21-2-384(a)(2)  Advanced In-Person Voting begins for the November General/Special Election. O.C.G.A. § 21-2-385(d)(1)
<b>October 17, 2017</b>	Date of October Special Election Runoff. O.C.G.A. § 21-2-501(a)(6)
<b>November 3, 2017</b>	Last day to mail or issue absentee ballots for November General/Special Election. O.C.G.A. § 21-2-384(a)
<b>November 7, 2017</b>	Date of November General/Special Election. O.C.G.A. §§ 21-5-9 & 21-2-540(c)(1)(A)
<b>December 1, 2017</b>	Last day to mail or issue absentee ballots for November General/Special Election Runoff. O.C.G.A. § 21-2-384(a)(2)
<b>December 5, 2017</b>	Date of December General/Special Election Runoff. O.C.G.A. § 21-2-501(a)(4)

When the last day for the exercise of any privilege or discharge of any duty prescribed or required by this chapter shall fall on a Saturday, Sunday, or legal holiday, the next succeeding business day shall be the last day for the exercise of such privilege or the discharge of such duty.*
