PEDDLERS LICENSE

(OPERATING IN UNINCORPORATED DAWSON COUNTY)

REQUIREMENTS FOR A BUSINESS LICENSE or OUT OF COUNTY BUSINESS REGISTRATION:

ORDINANCE REFERENCE:

Anyone engaged in business or carrying on business in unincorporated Dawson County is required to obtain a business license or out of county business registration. Engaging or carrying on business means doing or performing any act of selling any goods or services, or soliciting business, or offering any goods or services for sale primarily in an attempt to make a profit, including selling or performing services of the character of a wholesaler or retailer, or being involved in any of the functions performed as a manufacturer, or renting real or personal proper!) for less than 10 consecutive days; all of the foregoing performed either as an owner, operator or agent of any business, trade, profession, or occupation within Dawson County.

CONDITIONS FOR ALL PEDDLERS:

- MUST SUBMIT TO A BACKGROUND CHECK FOR ALL EMPLOYEES
- MUST DISPLAY COUNTY ISSUED ID AND LICENSE UPON REQUEST

CONDITIONS FOR STATIONARY (ROADSIDE) PEDDLERS:

ALLOWABLE ONLY IN A COMMERCIAL ZONE OR RESIDENTIAL AGRICULTURAL/EXURBAN (RA) ZONE.

PROHIBITED TO OPERATE IN ANY STATE OR COUNTY ROAD RIGHT OF WAY.

MUST HAVE WRITTEN PERMISSION FROM PROPERTY OWNER AND DESIGNATED PERMISSION PERIOD OF TIME. (Sample property authorization form is attached.)

MUST show and provide onsite adequate parking for customers outside of Right-of-Way .

FURTHER CONDITIONS FOR FOOD SALES:

HEALTH PERMIT (If required by Environmental Health - Contact Environmental Health- 706.265.2930- K. H. Long Government Building- Lower Level- 189 Highway 53 West, Suite 102, Dawsonville, GA 30534.) If you are selling only boiled peanuts, no permit is required by Environmental Health.

FOOD SALES ESTABLISHMENT LICENSE (If required by the Dept. of Agriculture – Contact the Dept. of Agriculture -800.473.0119 or 770.535.5955- 1195 Jesse Jewell Parkway, S.W. Gainesville, GA 30504.) If you are selling only boiled peanuts or uncut produce, no license is required by the Dept. of Agriculture.
